Merujuk pada Lampiran Keputusan Direksi PT Bursa Efek Indonesia No. Kep-00015/BEI/01-2021 tanggal 29 Januari 2021 tentang Peraturan Bursa Nomor I-E tentang Kewajiban Penyampaian Informasi (Ketentuan III.1.4) dimana apabila berdasarkan Laporan Keuangan Auditan terjadi perubahan lebih dari 20% pada Total Aktiva dan atau Total Kewajiban dibandingkan Laporan Keuangan Auditan Tahunan sebelumnya, maka bersamaan dengan penyampaian Laporan Keuangan Auditan dimaksud, Perseroan wajib menyampaikan penjelasan tertulis tentang penyebab perubahan lebih dari 20% pada Total Aktiva dan Total Kewajiban.

Referring to the attachment of the decision of the Directors PT Bursa Efek Indonesia No. Kep-00015/BEI/01-2021 as of January 29<sup>th</sup>, 2021 about Stock Exchange Regulation Number I-E regarding Obligation to Submit The Information (Provisions III.I.4) if based on the Audited Financial Statements there was a change of more than 20% in Total Assets and Total Liabilities compared to the previous Annual Audited Financial Statements, together with the submission of the Audited Financial Statements referred to, the Company is required to submit a written explanation of the causes of changes more than 20% in Total Assets and Total Liabilities.

Sesuai dengan Laporan Keuangan Konsolidasian PT Humpuss Intermoda Transportasi Tbk. ("Perseroan") dan Entitas Anaknya tanggal 31 Desember 2021, dapat kami sampaikan bahwa tidak adanya perubahan melebihi 20% pada pos total aktiva dan pos total kewajiban dibandingkan Laporan Keuangan Perseroan dan Entitas Anaknya tahun 2020.
